JCHS Parking Regulations:

1. All vehicles operated and/or parked on school grounds must have a valid NJ State registration and be properly covered by insurance, and must be listed on this application. (Please attach a copy of registration.)
2. The driver must be licensed, insured and have parental permission to drive to school as indicated at the bottom of this form. (Please attach a copy of your driver's license.)
3. Student drivers WILL adhere to the campus speed limit of 10 mph and WILL yield the right of way to pedestrians and school buses. NO speeding in, out or through the lot.
4. Students are permitted to only park in the designated student areas. Student spaces are outlined in white and are available on a first-come first-served basis.
5. Students are not permitted to park in the yellow or red spaces that are designated for faculty and visitors.

THE FOLLOWING PARKING IS RESTRICTED AND SUBJECT TO CONSEQUENCES:

- A. Handicapped spaces (unless proper tag is displayed and student processes DMV registered information in his/her name.
 - B. Fire zones
 - C. Faculty areas
 - D. Visitors' parking
 - E. Along curbs on Woodmere Avenue or along any curbed area in the main parking lot
 - F. On any grass area on school property
 - G. Parking in any way that blocks the driveways and/or obstructs the access of emergency vehicles to the school.
6. Student cars are prohibited in all fire lanes and in areas where their vehicle will prevent the flow of traffic or emergency access to the building. Park only in designated spots. If your car is parked illegally or found in faculty parking, you will be asked to move your car immediately and will be assigned a Saturday Detention. The assignment for the first parking violation is a Saturday Detention.
 7. If there isn't a spot available, students may park on the eastbound side of Westville Ave, the pool parking lot, or any of the side streets that allow parking. If a student parks in a teacher spot, on the grass, creates a spot, or parks anywhere other than a designated student area, the **first offense is a Saturday Detention.**
 8. The parking decal is to be displayed at all times on the side window behind the driver seat (bottom corner of the window). It must be properly affixed to the window. **DO NOT USE TAPE!**



9. If you permanently change cars you must remove the old decal and return it to the Main Office before a new decal will be issued.
10. If you need to take a different vehicle to school in an emergency situation, stop in the Main Office before school to get a temporary parking hang tag.
11. Students are not permitted in the parking area while school is in session. A pass to go to your car may be obtained through the Main Office.
12. Student drivers are not permitted to leave school grounds during the school day without permission. Student drivers will not leave campus illegally, or provide rides for others to do so.
13. **SEARCH AND SEIZURE:** (see notice below) Permission to park in the JCHS parking lot is granted subject to all rules and regulations of the school. By entering the parking lot, the person driving any vehicle is giving consent to a complete search of the vehicle by the school officials or police, if necessary. If any person in the car other than the driver is the current custodian of the vehicle, consent to a complete search of the vehicle by the school officials or police, if necessary. If any person in the car other than the driver is the current custodian of the vehicle, consent to search is deemed given by the custodian also.
14. Warning stickers will be used as necessary.
15. If you park illegally and your vehicle is not registered with the main office, your license plate number and vehicle information will be given to the West Caldwell Police. There will be a discipline consequence for parking without a parking decal.
16. Students who park in any illegal or unauthorized areas, or who drive inappropriately, or who break any school rules or procedures, may incur disciplinary consequences, including the loss of parking privilege.
17. Illegally parked and/or operated vehicles may be towed from school property at the owner's expense.

SEARCH AND SEIZURE NOTICE: I understand that, in accordance with New Jersey law, any vehicle, including its compartments and contents, entering or within a Drug Free School Zone may be subject to search by school officials and/or law enforcement personnel. This notice applies to all vehicles of any type on school property at any time – 24 hours a day, 7 days a week, and 365 days a year.
